1. VINSEUM's Commitment

2. General objectives

- Promoting a safe, healthy and respectful working environment in line with human and labour rights.
- Encouraging citizen participation, especially among local groups, in the cultural and educational life of the museum.
- Collaborating with social, educational and cultural organisations to foster social cohesion and accessible culture for all.
- Promoting cultural and environmental volunteering as a means of community engagement.

5. Governance and transparency

- The museum will act with ethics, integrity and transparency in its economic and institutional management.
- It commits to periodically evaluating the fulfilment of its social and environmental objectives.
- It will publish an annual sustainability report as part of its annual report, in order to monitor progress and share results with the public.
